

## Putting family at the heart of the matter

Changes were made to Legal Aid in 2012 which made it difficult for people to obtain legal aid to deal with family issues.

This has had a particular effect on parents who are unable to agree arrangements for their children.



What about those people who are not eligible for legal aid, but still struggle to afford legal fees? Often those people are left having to represent themselves in court, complete court forms or try and agree arrangements with an ex-partner at a time when they cannot even live in the same house. This has a negative impact on the children which can last beyond childhood.

At Sydney Mitchell we have put together a package of fees to deal with each stage of the process. In all cases there is a first meeting with a qualified specialist family lawyer at a fixed cost. The client can then chose which package they need for which stage of the process. This could simply be help completing court forms. Alternatively, it might be assistance at court. Clients can chose what package they need to suit their budget. Information as to what is included in the package is clear and so the client stays in control of what advice and assistance is given and what they will pay for that advice and assistance.
